Objection to Instructional Material

The policy of the Center Point - Urbana School district related to selection of learning materials states that any member of the school district community may formally challenge instructional and library materials used in the district's education program. CPU policy allows district patrons who are not directly involved in the selection of materials to make their own opinions known. The task of the reconsideration committee is to make an informed recommendation on the challenge. The meetings of the committee may be subject to the open meeting law. The main task of the reconsideration committee is to make a recommendation to the Superintendent when a citizen makes a written complaint against a library book, classroom material, or other instructional resource. District policy, regulations and procedures are considered when studying the challenged materials. In addition, CPUSD content experts may be consulted, as needed.

The reconsideration committee forwards their recommendation to the Superintendent who, in turn, makes the final decision. The reconsideration committee meets only if there are items to discuss. The reconsideration committee is made of eight members:

- One licensed employee designated annually, as needed, by the superintendent
- One teacher-librarian designated by the superintendent
- One member of the administrative team designated annually by the superintendent
- Three members of the community appointed annually, as needed, by the board
- Two high school students, selected annually by the high school principal
